

CHAPTER I

Introduction

The National Tiger Conservation Authority is a statutory body under the Ministry of Environment and Forests, constituted under enabling provisions of the Wildlife (Protection) Act, 1972, as amended in 2006, for strengthening tiger conservation, as per powers and functions assigned to it under the said Act.

The National Tiger Conservation Authority has been fulfilling its mandate within the ambit of the Wildlife (Protection) Act, 1972 for strengthening tiger conservation in the country by retaining an oversight through advisories/normative guidelines, based on appraisal of tiger status, ongoing conservation initiatives and recommendations of specially constituted Committees. 'Project Tiger' is a Centrally Sponsored Scheme of the Ministry of Environment and Forests, providing funding support to tiger range States, for in-situ conservation of tigers in designated tiger reserves, and has put the endangered tiger on an assured path of recovery by saving it from extinction, as revealed by the recent findings of the All India tiger estimation using the refined methodology.

Objectives of tiger conservation:-

To ensure maintenance of a viable population of Tigers in India for scientific, economic, aesthetic, cultural and ecological values, and to preserve for all times, areas of biological importance as a national heritage for the benefit, education and enjoyment of the people.



CHAPTER II

<u>Constitution of the National Tiger Conservation Authority including changes therein and its functions</u>

The National Tiger Conservation Authority was constituted with effect from 4.09.2006, for strengthening tiger conservation by, interalia, ensuring normative standards in tiger reserve management, preparation of reserve specific tiger conservation plan, laying down annual / audit report before Parliament, constituting State level Steering Committees under the Chairmanship of Chief Ministers and establishment of Tiger Conservation Foundation. Functions of the NTCA:

Powers and functions of the National Tiger Conservation Authority as prescribed under section 380 of the Wildlife (Protection) Act, 1972, as amended in 2006 are as under:-

- (a) to approve the tiger conservation plan prepared by the State Government under sub-section (3) of section 38V of this Act;
- (b) evaluate and assess various aspects of sustainable ecology and disallow any ecologically unsustainable land use such as, mining, industry and other projects within the tiger reserves;
- (c) lay down normative standards for tourism activities and guidelines for project tiger from time to time for tiger conservation in the buffer and core area of tiger reserves and ensure their due compliance;
- (d) provide for management focus and measures for addressing conflicts of men and wild animal and to emphasize on co-existence in forest areas outside the National Parks, sanctuaries or tiger reserve, in the working plan code;
- (e) provide information on protection measures including future conservation plan, estimation of population of tiger and its natural prey species, status of habitats, disease surveillance, mortality survey, patrolling, reports on untoward happenings and such other management aspects as it may deem fit including future plan conservation;
- (f) approve, co-ordinate research and monitoring on tiger, co-predators, prey habitat, related ecological and socio-economic parameters and their evaluation;
- (g) ensure that the tiger reserves and areas linking one protected area or tiger reserve with another protected area or tiger reserve are not diverted for ecologically unsustainable uses, except in public interest and with the approval of the National Board for Wild Life and on the advice of the Tiger Conservation Authority;
- (h) facilitate and support the tiger reserve management in the State for biodiversity conservation initiatives through eco-development and people's participation as per approved management plans and to support similar initiatives in adjoining areas consistent with the Central and State laws;
- (i) ensure critical support including scientific, information technology and legal support for better implementation of the tiger conservation plan;
- (j) facilitate ongoing capacity building programme for skill development of officers and staff of tiger reserves, and
- (k) perform such other functions as may be necessary to carry out the purposes of this Act with regard to conservation of tigers and their habitat.

CHAPTER III

Meetings of the National Tiger Conservation Authority and important decisions taken therein

1. Decisions taken in the ninth meeting of the National Tiger Conservation Authority held under the Chairmanship of Smt. Jayanthi Natarajan, Minister for Environment and Forests on the 19th June, 2013, in Room No. 403, Ministry of Environment and Forests, New Delhi

The ninth meeting of the National Tiger Conservation Authority (NTCA) was held under the Chairmanship of Smt. Jayanthi Natarajan, Minister for Environment and Forests and Chairperson, NTCA, on the 19th of June, 2013 in Room No. 403, Ministry of Environment and Forests, Paryavaran Bhawan, New Delhi.

The Chairperson, NTCA welcomed the members and initiated the deliberations. It was stated that India has a long and good track record of conserving its wild tigers, while having the unique distinction of being a pioneer country in this regard by launching the flagship scheme of Project Tiger in 1973. Over the years, the said project coverage has increased from 9 reserves to 43 tiger reserves, spread over 17 States where tigers occur. It was informed that 3 new reserves, viz., Kawal in Andhra Pradesh, Sathyamangalam in Tamil Nadu and Mukandra Hills (including Darrah, Jawahar Sagar and Chambal Wildlife Sanctuaries) in Rajasthan have been recently added, and process is on for declaring the Rajaji National Park as a Tiger Reserve. The core and buffer areas of tiger reserves constitute more than 2% of our country's geographical area.

The Chairperson, NTCA further apprised the members that the focus on tiger conservation has been sharpened and several initiatives have been taken in the recent past as indicated below:

- The Centrally Sponsored Scheme of Project Tiger was revised in August, 2011. Its allotment was stepped up for the XI Plan to Rs. 1216.86 crores, especially to support the States for securing inviolate space for tigers. A number of additional components have also been included: (i) Change in the funding pattern in respect of North Eastern States (90:10), (ii) raising compensation for man-animal conflict to Rs. 2 lakhs, (iii) acquisition of private land for making the core/critical tiger habitat inviolate, (iv) establishment of Tiger Safari, interpretation/awareness centres under the existing component of 'coexistence agenda in buffer/fringe areas', and management of such centres through the respective Panchayati Raj Institutions, (v) re-introduction of Cheetah.
- The allocation for the ongoing Project Tiger Scheme during the XII Plan is Rs. 1245 crores. This is an enhancement compared to Rs. 792 crores during the XI Plan.
- Other initiatives include: (i) giving "in-principle" approval to three new tiger reserve, viz. Pilibhit (Uttar Pradesh), Ratapani (Madhya Pradesh) and Sunabeda (Odisha) (ii) in-principle approval for use of CAMPA funds towards village relocation from core areas, (iii) completion of 'e-surveillance' project in Corbett, (iv) launching 'M-STrIPES' monitoring protocol, (v) launching of Tiger Reserve level year round monitoring using camera traps (Phase-IV), (vi) supporting patrolling in tiger rich areas outside tiger reserves, (vii) capacity building of field officials for wildlife crime investigation in collaboration with the CBI, (viii) advising some of the States for CBI investigation in tiger / rhino poaching cases to break the nexus, and (ix) strengthening bilaterals with Nepal, Bangladesh, Russian Federation and Bhutan.

It was also informed that an aggressive 'tiger agenda' is being followed in the core areas of tiger reserves, and the strategy now is to ensure an equally aggressive 'inclusive' agenda in the peripheral / buffer areas to benefit people who live in such areas. Under Project Tiger, funding support is provided for such activities in the buffer. The status of tiger and many wild animals

continue to remain endangered. The Special Tiger Protection Force (STPF) has been raised and deployed in three tiger reserves, viz. Bandipur (Karnataka), Tadoba-Andhari (Maharashtra) and Pench (Maharashtra). The NTCA is committed to support the other tiger States as well in this regard, and MOU has been signed with several States like Rajasthan, Uttar Pradesh, Uttarakhand and Odisha.

It was highlighted that tiger and other wildlife cannot be protected by excluding local people, and hence the endeavour all along has been to deploy local workforce in protection. In all, approximately 24 lakh mandays are generated annually with 50% central assistance amounting to around Rs. 24 crores (excluding matching 50% share given by States) under Project Tiger. Many local tribes constitute such local workforce (besides non-tribals), eg. Baigas, Gonds in Madhya Pradesh, Gonds in Maharashtra, Chenchus in Andhra Pradesh, Sholigas in Karnataka, Gujjars in Uttarakhand and Irulas in Tamil Nadu to name a few. The deployment of such local tribals has been fostered/encouraged in the last two years.

The process of providing enabling provisions in the Wildlife (Protection) Act, 1972 is ongoing for strengthening the implementation of the CITES, besides enhancement of penalties for contravention of provisions of the Act.

The Chairperson, NTCA informed the members that the progress towards tiger reserve specific Phase-IV monitoring has been reviewed by her, and each tiger reserve now has a camera trap data base of individual tigers, which facilitates close monitoring. Such data, in combination with those already available from the country level assessment would be used for creating a National Repository of Camera Trap Photographs of individual tigers.

The Chairperson, NTCA apprised the members of her visit to Kaziranga and Sariska tiger reserves for field appraisal, while stating that the States are being actively engaged to address the problem of tigers moving into human dominated areas. Likewise, every individual tiger death is being monitored, besides sensitizing States for intelligence based protection. The SOPs issued by the NTCA were also highlighted.

The Chairperson, NTCA expressed her confidence that with the support of the States and Civil Society, the initiatives taken for wildlife conservation would be successful.

This was followed by deliberations on the agenda items as indicated below:

Agenda Item No. 1

Confirmation of minutes of the eighth meeting, including action taken

The Chairperson, NTCA solicited comments on the minutes of the eighth meeting of the NTCA. The NTCA confirmed the minutes of its eighth meeting held on 12th October, 2012.

Agenda Item No. 2

Apprising the Members of the NTCA on compliance of the statutory requirements, guidelines and advisories issued

With the permission of the Chair, the Member Secretary, NTCA apprised the members on compliance of the statutory requirements, guidelines/advisories issued as detailed in the agenda notes, and the supplementary information provided on Agenda 2(1):



It was also informed that the process for the 3rd round (2013-14) of country wide assessment of status of tigers, co-predators, prey and habitat using the refined methodology has been initiated, in addition to the 3rd round of independent Management Effectiveness Evaluation (MEE) of Tiger Reserves (2013-14).

The Authority took note of the above with the following observations from members:

- (i) S/Shri Brijendra Singh, Dr. M.K. Ranjitsinh and Smt. Maneka Gandhi, Members, NTCA desired that the Amangarh range of the Bijnore District falling in Uttar Pradesh should be notified for tiger conservation since the said area was earlier part of the Corbett Tiger Reserve (The UP Government has already notified the Amangarh area as a buffer of the Corbett Tiger Reserve).
- (ii) Smt. Maneka Gandhi, MP and Member, NTCA emphasized on expediting the notification of the Pilibhit forest area in Uttar Pradesh as a tiger reserve, and the matter should be taken up with the Chief Minister of Uttar Pradesh. The Member Secretary, NTCA informed that the MEF and Chairperson, NTCA has already addressed the Chief Minister in this regard and the matter was being pursued at the level of Chief Secretary and Principal Secretary, Forest Department, Government of Uttar Pradesh. The Chairperson informed that this would be taken up at her level with the Chief Minister, Uttar Pradesh.
- (iii) Dr. M.K. Ranjitsinh, Member, NTCA desired that the newly notified Mukandra Hills Tiger Reserve should be renamed by restoring its historical name as "Mukundwara". The Chairperson, NTCA directed for informing the State accordingly.
- (iv) Smt. Maneka Gandhi, MP and Member, NTCA highlighted the problems in the Rajaji National Park of Uttarakhand and desired that the support for tiger



reserve should be conditional to solving of such issues. The suggestion made

by the Member was noted.

Dr. A.J.T. Johnsingh, Member, NTCA while welcoming the notification of (v) Rajaji as a tiger reserve desired that the Surahi range of Terai East Division. Uttarakhand should be conserved for rhinos. The Chairperson, NTCA stated that this would be taken up with the Chief Minister of the State. Dr. A.J.T. Johnsingh, while referring to the Western Ghats Landscape, also desired that details of 'effort' done should also figure in the tiger assessment report. The suggestion of the member was noted.

Dr. M.K. Ranjitsinh, Member, NTCA desired that during the country level (vi) assessment of tiger a separate category should be made for recording of subadult tigers/young ones, as well as tiger mortality for obtaining information on recruitment / death. He also suggested for categorizing the tiger deaths due to various causes: viz., internecine fight, poaching etc. The Member, while praising the independent Management Effectiveness Evaluation of Tiger Reserves desired that the status of habitat, survival of endangered species in tiger reserves should also be evaluated. The Member Secretary, NTCA informed the member that such issues are already considered. suggestions made by the member were noted.

Agenda Item No. 3

Approval of budget / expenditure schedules for the year 2012-13

The NTCA approved and ratified the following:

The form of financial statements together with balance sheet, income and 1. expenditure account, receipts and payment statements as provided at Annexure-II of the agenda notes for the year 2012-13.


Approved the allocation of Rs. 15,56,18,594/- to the NTCA for the year 2012-13, 2. and the expenditure incurred therein leaving an unutilized amount of Rs.

9,92,50,387/-.

Smt. Maneka Gandhi, MP and Member, NTCA desired that the NTCA should provide more support for capacity building / training rather than publications. She also desired to know the details of expenditure on publications. The Member Secretary, NTCA informed the member about such details as provided in the agenda notes. The Chairperson, NTCA directed to take note of the observations made by the member, while providing the details.

Agenda Item No. 4

Posting and tenure of Field Directors

The Member Secretary, NTCA informed that in the past, the Steering Committee of Project Tiger had directed that the State Governments should send a panel of names suitable for posting as Field Directors of tiger reserves. Time and again, Project Tiger / NTCA has been pursuing with States for the same. However, over the years, this process could not be followed for want of such panel from States. The status of protection and field implementation largely depends on the leadership shown by the Field Director. Hence, a tripartite Memorandum of Understanding, linked to fund flows has also been implemented since 2009-10, between the NTCA/Project Tiger, State Government and the Field Director.

Hence, the proposal has been made that the States may be directed under section 38O (2) of the Wildlife (Protection) Act, 1972 for sending a panel of names to Project Tiger / NTCA for recommendation before posting, with a commitment for a minimum tenure of three years in the tiger reserve under normal circumstances. This arrangement would be a consultation for professional reasons, not amounting to concurrence, and should not be construed as encroaching in the State's administrative domain.

Dr. M.K. Ranjitsinh, Member, NTCA, while appreciating the proposal desired that an officer trained in wildlife management should be preferred during selection. Smt. Maneka Gandhi, MP and Member, NTCA also appreciated the proposal while emphasizing the need for posting the motivated officers in tiger reserves, besides developing special wildlife training module for field officials. Shri Brijendra Singh, Member, NTCA, while supporting the proposal desired that an officer who has served as a Wildlife Warden / Deputy Director in a tiger reserve should be preferred for such postings. The Chairperson, NTCA informed that the Wildlife Institute of India is conducting the diploma course for field personnel, while directing for taking note of the observations made by the members.

The NTCA approved the proposal.

Agenda Item No. 5

Providing ration allowance to the field staff of tiger reserves under the ongoing Centrally Sponsored Scheme of Project Tiger

The Member Secretary, NTCA highlighted the agenda item as provided in the agenda notes, while stating that a lumpsum rate of Rs. 860/- per month has been proposed for all categories of field staff in tiger reserves, below the level of Range Officers,/Deputy Rangers. The said rate has already been approved for the personnel of Special Tiger Protection Force.

Dr. M.K. Ranjitsinh, Member, NTCA desired that such allowance should be more for lower level functionaries. Shri P.K. Sen, Member, NTCA highlighted the need for differentiating the 'ration allowance' from the "project allowance", since the latter has different rates for various field level officials. He also desired that the workforce deployed in tiger reserves on a day to day basis should also be provided such benefits. The Member Secretary, NTCA informed that the States would be advised to support the same through the Tiger Conservation Foundation, as being practiced in some States. The Chairperson, NTCA directed for obtaining further comments from members to firm up the proposal.


Shri Sajjan Singh Verma, MP and Member, NTCA highlighted the recent tiger deaths in Bandhavgarh, while emphasizing the need for fixing accountability on senior officials. Smt. Maneka Gandhi, MP and Member, NTCA also felt the sme. The Chairperson, NTCA asked for an update from the Chief Wildlife Warden, Madhya Pradesh, who informed that two forest personnel have been suspended and an enquiry has been initiated in the said case. The members felt that non-compliance of the advisories issued by the NTCA should be viewed seriously and must be linked with fund flow.

Additional Agenda Item No. 2 proposed by Dr. A.J.T. Johnsingh, Member, NTCA for eradication of *Opuntia dillenii* from Mudumalai landscape

It was agreed that funding support for eradication of *Opuntia dillenii* from Mudumalai landscape may be provided under the ongoing Centrally Sponsored Scheme of Project Tiger, as per the provisions of the Tiger Conservation Plan through the Annual Plan of Operation.

CHAPTER V

Monitoring and Evaluation

"Project Tiger" was launched in April, 1973 with the objective "to ensure maintenance of a viable population of tigers in India for scientific, economic, aesthetic, cultural and ecological values, and to preserve for all times, areas of biological importance as a national heritage for the benefit, education and enjoyment of the people".

The Project has been successfully implemented, and at present there are 44 tiger reserves in 17 States, covering an area of 66777.44 sq.km. (core/critical tiger habitat and buffer/peripheral areas).

Project Tiger is an ongoing Centrally Sponsored Scheme. Conservation of endangered species and their habitat, strengthening and enhancing the Protected Area Network, control of poaching, monitoring, research and ensuring people's participation in wildlife conservation have been accorded high priority in the National Wildlife Action Plan and the Wildlife Conservation Strategy, 2002.

Based on the recommendations of the NBWL, chaired by the Prime Minister, a Task Force was set up in 2005 to look into the problems of tiger conservation in the country and to suggest measures for improvement. To implement the recommendations of the said Task Force, the Wildlife (Protection) Act, 1972 was amended in 2006 to provide a separate chapter for strengthening tiger conservation, interalia, with enabling provisions, for creating the National Tiger Conservation Authority. The said Authority was constituted as a statutory body on 4.9.2006 under the Ministry of Environment and Forests.

During present plan period, under the ongoing Centrally Sponsored Scheme of Project Tiger, 100% central assistance is being made available to States for expenditure on all non-recurring items; for recurring items, the central assistance is restricted to 50% of the expenditure, while the matching grant is provided by the Project States. In case of the North Eastern States, the ratio of matching grant is 90:10.

At present, the following activities are supported under the Centrally Sponsored Scheme of Project Tiger:

(a) Some of the major non-recurring activities supported by the project include civil works like patrolling camps, project allowance for the staff deployed in tiger reserves, development and reinforcement of roads and wireless communication network, development of water impounding structures like ponds, anicuts, establishment of barriers, voluntary village relocation, creation of veterinary facilities, compensation to the dependents of staff killed while performing duty and the like.

(b) The works of recurring nature include antipoaching squads, deployment of fire watchers, fire protection measures, weed eradication and indigenous grass management, compensation to fringe villagers for cattle depredation by carnivores, field research, estimation and monitoring of tigers and other wild animals, deployment of patrolling

camp watchers and the like. Each tiger reserve has its own site-specific Tiger Conservation Plan which is a statutory requirement.

Technical and administrative monitoring mechanisms

The following technical and administrative monitoring mechanisms are in place:

i. The tiger population is estimated once every four years using a refined methodology of double sampling using camera traps in mark-recapture statistical framework at the landscape level. The last such country level assessment was done in the year 2010. The country level tiger population has shown an increasing trend with a population estimate of 1706, lower and upper limits being 1520 and 1909 respectively in the recent all India tiger estimation (2010), as compared to the last country level estimation of 2006, with an estimate of 1411, lower and upper limits being 1165 and 1657 respectively. iii. The 'M-STrIPES' (Monitoring System for Tigers' Intensive Protection and Ecological Status) has been launched in 7 tiger reserves on a pilot basis for effective field patrolling and monitoring.

iv. A year round, ongoing tiger reserve level monitoring (Phase-IV) is being implemented in all tiger reserves as per protocol issued in this regard using camera traps and other methods. In areas with low tiger density, and those affected by left wing extremism (where camera trapping is not feasible), DNA analysis from scats is being done for obtaining the minimum tiger number.

v. With the help of the National Informatics Centre (NIC) process has been initiated for an online website for village relocation monitoring in the Sariska Tiger

Reserve (Rajasthan).



Milestone initiatives taken by the Government of India for protection of tigers in the country

Legal steps

- 1. Amendment of the Wild Life (Protection) Act, 1972 in 2006 to provide enabling provisions for constituting the National Tiger Conservation Authority and the Tiger and Other Endangered Species Crime Control Bureau.
- 2. Enhancement of punishment for offence in relation to the core area of a tiger reserve or where the offence relate to hunting in the tiger reserves or altering the boundaries of tiger reserves, etc.

Administrative steps

3. Strengthening of antipoaching activities, including special strategy for monsoon patrolling, by providing funding support to tiger reserve States, as proposed by them, for deployment of antipoaching squads involving ex-army personnel or home guards, apart from workforce comprising of local people, in addition to strengthening of communication and wireless facilities.

- 4. Constitution of the National Tiger Conservation Authority with effect from the 4th September, 2006, for strengthening tiger conservation by, inter alia, ensuring normative standards in tiger reserve management, preparation of reserve specific tiger conservation plan, laying down annual audit report before Parliament, constituting State level Steering Committees under the Chairmanship of Chief Ministers and establishment of Tiger Conservation Foundation.
- 5. Constitution of a multidisciplinary Tiger and Other Endangered Species Crime Control Bureau (Wildlife Crime Control Bureau) with effect from the 6th June, 2007 to effectively control illegal trade in wildlife.
- 6. The in-principle approval has been accorded by the National Tiger Conservation Authority for creation of three new tiger reserves, and the sites are: Pilibhit (Uttar Pradesh), Ratapani (Madhya Pradesh) and Sunabeda (Odisha). Final approval has been accorded to Kudremukh (Karnataka) and Rajaji (Uttarakhand) for declaring as a tiger reserve. The State Governments have been advised to send proposals for declaring the following areas as tiger reserves: (i) Bor (Maharashtra), (ii) Suhelwa (Uttar Pradesh), (iii) Guru Ghasidas National Park (Chhattisgarh), (iv) Mhadei Sanctuary (Goa) and (v) Srivilliputhur Grizzled Giant Squirrel / Megamalai Wildlife Sanctuaries / Varushanadu Valley (Tamil Nadu).
- 7. The revised Project Tiger guidelines have been issued to State Governments for strengthening tiger conservation, which apart from ongoing activities, inter alia, include financial support to States for enhanced village relocation or rehabilitation package for people living in core or critical tiger habitats (from Rs. 1 lakh per family to Rs. 10 lakhs per family), rehabilitation or resettlement of communities involved in traditional hunting, mainstreaming livelihood and wildlife concerns in forests outside tiger reserves and fostering corridor conservation through restorative strategy to arrest habitat fragmentation.
- 8. A scientific methodology for estimating tiger (including co-predators, prey animals and assessment of habitat status) has been evolved and mainstreamed. The findings of this estimation and assessment are bench marks for future tiger conservation strategy.
- 9. The 17 tiger States have notified the core/critical tiger habitat (36988.28 sq. km.), and the buffer/peripheral area (29789.06 sq.km.) of all the 44 tiger reserves in the country, under section 38V of the Wild Life (Protection) Act, 1972, as amended in 2006.

Financial steps

10. Financial and technical help is provided to the State Governments under various Centrally Sponsored Schemes, such as Project Tiger and Integrated Development of Wildlife Habitats for enhancing the capacity and infrastructure of the State Governments for providing effective protection to wild animals.

International Cooperation

- 11. India has a bilateral understanding with Nepal on controlling trans-boundary illegal trade in wildlife and conservation, apart from a protocol on tiger conservation with China.
- 12. A protocol has been signed in September, 2011 with Bangladesh for conservation of the Royal Bengal Triger of the Sunderban.
- 13. A sub-group on tiger and leopard conservation has been constituted for cooperation with the Russian Federation.

- 14. A Global Tiger Forum of Tiger Range Countries has been created for addressing international issues related to tiger conservation.
- 15. During the 14th meeting of the Conference of Parties to CITES, which was held from 3rd to 15th June, 2007 at The Hague, India introduced a resolution along with China, Nepal and the Russian Federation, with direction to Parties with operations breeding tigers on a commercial scale, for restricting such captive populations to a level supportive only to conserving wild tigers. The resolution was adopted as a decision with minor amendments. Further, India made an intervention appealing to China to phase out tiger farming and eliminate stockpiles of Asian big cats body parts and derivatives. The importance of continuing the ban on trade of body parts of tigers was emphasized.
- 16. Based on India's strong intervention during the 62nd meeting of the Standing Committee of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) at Geneva from 23-27 July, 2012, the Convention on International Trade in Endangered Species of Wild Fauna and Flora Secretariat has issued a notification No. 2012/054 dated the 3rd September, 2012 to Parties to fully implement Decision 14.69 and report to the Secretariat by 25 September, 2012 (Progress made on restricting captive breeding operations of tigers etc.).
- 17. As a part of active management to rebuild Sariska and Panna Tiger Reserves where tigers have become locally extinct, reintroduction of tigers and tigresses have been done. The successful reintroduction of wild tigers in Sariska is a unique exercise and is the first of its kind in the world. A reintroduced tigress has recently littered and two cubs have also been camera trapped. The tiger reintroduction initiative at Panna (MP) has also been very successful and reintroduced tigers are breeding.
- 18. Special advisories issued for in-situ build up of prey base and tiger population through active management in tiger reserves having low population status of tiger and its prey.

Creation of Special Tiger Protection Force (STPF)

- 19. The policy initiatives announced by the Finance Minister in his Budget Speech of the 29th February, 2008, inter alia, contains action points relating to tiger protection. Based on the one time grant of Rs. 50.00 crore provided to the National Tiger Conservation Authority (NTCA) for raising, arming and deploying a Special Tiger Protection Force (STPF), the proposal for the said force has been approved by the competent authority for 13 tiger reserves. The States of Karnataka and Maharashtra have already created and deployed the STPF.
- 20. In collaboration with TRAFFIC-INDIA, an online tiger crime data base has been launched, and Generic Guidelines for preparation of reserve specific Security Plan has been evolved.

Recent initiatives

- 21. Implementing a tripartite Memorandum of Understanding (MOU) with tiger States, linked to fund flows for effective implementation of tiger conservation initiatives.
- 22. Special crack teams sent to tiger reserves affected by left wing extremism and low population status of tiger and its prey.
- 23. Chief Ministers of States having tiger reserves affected by left wing extremism and low population status of tiger and its prey addressed for taking special initiatives.

- 24. Steps taken for modernizing the infrastructure and field protection, besides launching 'Monitoring system for Tigers' Intensive Protection and Ecological Status (M-STrIPES)' for effective field patrolling and monitoring.
- 25. Steps taken for involvement of Non-Governmental Experts in the ongoing all India tiger estimation.
- 26. Initiatives taken for improving the field delivery through capacity building of field officials, apart from providing incentives.
- 27. The second round of country level tiger status assessment completed in 2010, with the findings indicating an increase with a tiger population estimate of 1706, lower and upper limits being 1520 and 1909 respectively, as compared to the last country level estimation of 2006, with an estimate of 1411, lower and upper limits being 1165 and 1657, respectively. At present, India has the maximum number of tigers and its source areas amongst the 13 tiger range countries in the world, owing to its long history of conserving the species through Project Tiger (2% of country's geographical area spread out in 44 tiger reserves in 17 States).
- 28. A report on Management Effectiveness Evaluation (MEE) of Tiger Reserves was released on 28th July, 2011, containing the second round of independent assessment based on refined criteria done in 2010-11 for 39 tiger reserves. Out of 39 tiger reserves, 15 were rated as 'very good', 12 as 'good', 8 as 'satisfactory' and 4 as 'poor'.
- 29. Providing special assistance for mitigation of human-tiger conflicts in problematic areas.
- 30. Regional Offices of the National Tiger Conservation Authority are operational at Nagpur, Bengaluru and Guwahati.
- 31. A 'Standard Operating Procedure' for dealing with tiger deaths has been issued, based on advisories of Project Tiger / National Tiger Conservation Authority, with inputs from Wildlife Crime Control Bureau, State officials and experts, fine tuned to meet the present challenges.
- 32. A 'Standard Operating Procedure' for dealing with straying tigers in human dominated landscape has been issued.
- 33. A 'Standard Operating Procedure' for disposing tiger/leopard carcass/body parts has been issued.
- 34. The Revised Cost Estimates for Project Tiger was approved on 11.8.2011 for an upward revision of the cost estimates for the ongoing Centrally Sponsored Scheme of Project Tiger during the XIth Plan period from 650 crore to Rs. 1216.86 crore of central assistance to support States in village relocation from core areas of tiger reserves. Several new components were added to the Project, viz.:
- (i) Change in the funding pattern in respect of North Eastern States (90:10)
- (ii) Raising compensation for man-animal conflict to Rs. 2 lakhs
- (iii) Acquisition of private land for making the core/critical tiger habitat inviolate
- (iv) Establishment of Tiger Safari, interpretation/awareness centres under the existing component of 'co-existence agenda in buffer/fringe areas', and management of such centres through the respective Panchayati Raj Institutions
- (v) Re-introduction of Cheetah
- 35. Launching of Phase-IV tiger reserve level, continuous monitoring of tigers using camera traps and building up data on photo captures of individual tigers.

- 36. Launching the creation of a national repository of camera trap photo IDs of individual tigers.
- 37. In-principle approval for use of CAMPA funds towards village relocation from core areas.
- 38. Completion of e-surveillance project in Corbett.
- 39. Comprehensive guidelines under section 38O 1 (c) of the Wildlife (Protection) Act, 1972 issued for Project Tiger and Tourism in Tiger Reserves on 15th October, 2012.
- 40. Under active management, permission accorded for translocation of two tigresses from Ranthambhore to Sariska (Rajasthan), besides one straying sub-adult male tiger from Panna to Satpura (Madhya Pradesh), and one straying tiger from Pilibhit to Dudhwa Tiger Reserve (Uttar Pradesh).
- 41. A bilateral arrangement has been recently formalized with Bangladesh on tiger conservation. Our delegations are interacting with Nepal and China within the framework of existing bilateral arrangements. A sub-group on tiger/leopard conservation has been constituted for cooperation with the Russian Federation, which has met recently.
- 42. Field level workshops for capacity building of field officers to deal with straying tigers have been organized at Tadoba and Dudhwa Tiger Reserves (2013).
- 43. NTCA teams sent for field appraisal of tiger deaths, Project Tiger implementation etc.
- 44. Process underway for providing enabling provisions in the Wildlife (Protection) Act, 1972, to strengthen our implementation of the CITES and towards enhancement of penalties for contravention of provisions of the Act.
- 45. Kawal (Andhra Pradesh), Sathyamangalam (Tamil Nadu), Mukandra Hills (Darrah, Jawahar Sagar and Chambal Wildlife Sanctuaries) (Rajasthan) and Nawegaon-Nagzira (Maharashtra) have been notified by the State Governments as Tiger Reserve.
- 46. Action has been initiated for the next round (2014) of country level status assessment of tiger, co-predators, prey and habitat, using the refined methodology, in collaboration with tiger States and the Wildlife Institute of India.
- 47. Action has been initiated for the next round (2014) of Independent Management Effectiveness Evaluation of Tiger Reserves.

CHAPTER VIII

Annual Plan of the National Tiger Conservation Authority

- 1. Based on the Tiger Task Force recommendations constituted by the National Board for Wildlife chaired by the Prime Minister, the Wildlife (Protection) Act, 1972 has been amended in 2006, to provide a separate chapter (Chapter IVB) for constituting the National Tiger Conservation Authority. The said Authority has been constituted with effect from 4th September, 2006.
- 2. The functions of NTCA are provided under section 380 of the Wildlife (Protection) Act, 1972, as amended in 2006. The NTCA would address the ecological as well as administrative concerns for conserving tigers, by providing a statutory basis for protection of tiger reserves, apart from providing strengthened institutional mechanisms for the protection of ecologically sensitive areas and endangered species. The Authority would also ensure enforcing of guidelines for tiger conservation and monitoring compliance of the same, apart from placement of motivated and trained officers having good track record as Field Directors of tiger reserves. It would also facilitate capacity building of officers and staff posted in tiger reserves, apart from a time bound staff development plan.
- 3. During the financial year 2013-14, an amount of Rs. 700.00 lakhs has been provided to the NTCA as Grants-in-aid. The previous balance of Rs. 992.50 lakhs has been got revalidated for use during 2013-14.
- 4. Consequent to the Wildlife (Protection) Amendment Act, 2006, coming into force with effect from 4.9.2006, based on the enabling provisions under Section 38N of the said Act, the posts borne on the establishment strength of the MoEF and working in Project Tiger, have been transferred to the NTCA.
- 5. Details of sanctioned posts at NTCA Headquarter and Regional Offices of NTCA at Nagpur, Guwahati and Bangalore are as under:



- 7. Section 63(giv) and (gv) provide for rule relating to Annual Statement of Accounts of the NTCA as well as submission of its Annual Report under Sections 38R and 38S of the said Wildlife (Protection) Act, 1972, respectively.
- 8. Proposals relating to contractual services / professional service with funding support from NTCA are approved by the Technical Committee of the NTCA. Director (IFD) is a member of the said Technical Committee. In case due to unavoidable circumstance, if the IFD is not represented in the meeting of the Technical Committee of the NTCA, the proposals would be approved on the basis of majority decision, and the IFD would be apprised of the outcome through the minutes of the meeting of the said Committee.
- 9. Accounts of the National Tiger Conservation Authority (NTCA) for the year 2013-14 have been compiled. The final audit of the accounts of the NTCA was conducted by the Principal Director of Audit, Scientific Department of CAG under Section 19(2) of C&AGs (Duties, powers and conditions of Service) Act, 1972 read with Section 38 E (5) & (6) of the Wildlife (Protection) Act, 1972. Copy of the Accounts for the year 2013-14 containing receipt and payments accounts, income and expenditure accounts and balance sheet as on 31st March, 2014 with schedule is placed as Annexure (iv) to (xviii). Audit Report submitted by the Principal Director of Audit, Scientific Department of CAG is furnished in Annexure-(xix to xx).





We have audited the attached Balance Sheet of National Tiger Conservation Authority, New Delhi (NTCA) as on 31st March 2014, the Income & Expenditure Account and the Receipts & Payment Account for the year ended on that date under Section 19(2) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971 read with Section 38E (5) of the Wildlife (Protection) Act, 1972 as amended in 2006. These financial statements are the responsibility of the NTCA's management. Our responsibility is to express an opinion on these financial statements based on our audit.

- 2. This Separate Audit Report contains the comments of the Comptroller and Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/ CAG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.
- 4. Based on our audit, we report that:
- (i) We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit.
- (ii) The Balance Sheet, Income & Expenditure Account and Receipt & Payment Account dealt with by this report have been drawn up in the format approved by the Ministry of Finance.
- (iii) In our opinion, proper books of accounts and other relevant records have been maintained by the NTCA as required under Section 38R of the Wildlife (Protection) Act, 1972 as amended, in so far as it appears from our examination of such books.

1. Schedule 8 - Fixed Assets, Rs 388.08 lakh

1.1 "Tiger Protection Expenses" amounting to Rs. 3,97,680/- incurred during 2012-13 for Non-Invasive Genetic Monitoring of Tiger in Tiger Reserve was included as Office Equipments in Schedule 8 – Fixed Assets resulting in an overstatement of Assets and Understatement of Expenditure by Rs 3,97,680.00.

Depreciation may also be worked out accordingly under Office Equipments head.

No compliance has been made regarding above in the Annual Accounts of NTCA for the year 2013-14.

B. Income and Expenditure Account

Schedule 22 - Grants, Rs 349.76 lakh

NTCA released Rs 320.65 lakh from Capital Grant (256.52 lakh on 19.08.2013 and Rs 64.13 lakh on 04.03.2014) to Bandipur Tiger Conservation Foundation for providing accommodation facility to the staff of the Special Tiger Protection Force (STPF) deployed in Maddur, Handpost and Thithimathi. This amount was shown as expenditure in Schedule No. 22- Grants, instead of Schedule-11 B "Loans Advances and Other Assets" as Grants-in-Aid to Bandipur Tiger Conservation Foundation. This resulted in overstatement of Expenditure and understatement of Assets to the extent of Rs 320.65 lakh.


C. Grants-in-aid

NTCA had unutilised grant of Rs. 974.96 lakh as on 31-03-2013. During the year 2013-14, NTCA received grants-in-aid of Rs. 700.00 lakh and miscellaneous receipt of Rs 1.41 lakh. Total grants-in-aid of Rs. 1676.37 lakh was available for expenditure. Out of this amount, NTCA utilised Rs. 1350.31 lakh and Rs. 326.06 lakh remained unutilised grant as on 31st March 2014.

D. Management letter

Deficiencies which have not been included in the Audit Report have been brought to the notice of the Member Secretary, National Tiger Conservation Authority through a management letter issued separately for remedial/corrective action.

- (v) Subject to our observations in the preceding paragraphs, we report that the Balance Sheet, Income & Expenditure Account and Receipt & Payment Account dealt with by this report are in agreement with the books of accounts.
- (vi) In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Account, and subject to the significant matters stated above and other matters



Annexure

- 1. Utilisation Certificates of Grants --in-aid of Rs. 507.93 lakh paid to various Tiger Reserves for phase IV monitoring and to WII and Others for research works is still outstanding as on 31.03.2014.
- 2. As per GFR, while releasing grants to quasi-Government Institutions, a condition should be laid down that assets acquired wholly or substantially out of Government grants, shall not be disposed off without obtaining the prior approval of the sanctioning authority. It was however observed, that this conditions has neither been incorporated in the Memorandum of Understanding (MOU) nor in the sanction order releasing funds to the WII, Tiger Reserves and others upto 31st March 2013. Though this condition has been incorporated in the MoU, but the list of assets created out of Grants released by NTCA amounting to Rs. 988.80 lakh to WII & Rs. 697.56 lakh to various Tiger Reserves & Others upto 2013-14 has not been obtained from them. The same may be obtained from them.
- 3. Investment Register was not maintained, the same may be maintained now. Accrued interest on investment upto 31.03.2014 was neither ascertained from the Bank nor shown in the Annual Accounts, Schedule-11.
- 4. Purchase of one briefcase worth Rs 2400.00 was included as Office Equipments in Schedule 8 Fixed Assets resulting in an overstatement of Assets and Understatement of Expenditure by Rs 2400.00.
- 5. During the audit of NTCA for the year 2012-13, the following shortcomings were pointed out but no compliance has been made in the Annual Accounts of NTCA for the year 2013-14.
- (i) NTCA paid Rs 372.20 lakh during 2010-11 (Rs 111.66 lakh) 2011-12 (Rs 223.32 lakh) and 2012-13 (Rs 37.22 lakh) to M/s Binomial Solution Pvt. Ltd., for development of "e- eye" Real Time Anti-poaching 24*7 surveillance system in Corbet Tiger Reserve. The above amount was paid under Service Contract Agreement, which included components of Computer Peripheral etc., lease line connectivity, Civil works and Consultancy. Out of Rs 372.20 lakh, Rs 37.22 lakh was shown as office Equipment under Schedule 8 Fixed Assets, Rs 186.10 lakh was shown as advance payment under Schedule 11 and balance Rs 148.88 lakh was treated as expenditure during 2011-12. As the payment under the project was capital in nature, Rs 334.98 lakh (Rs 372.20 lakh Rs 37.22 lakh) may be capitalized under respective head of assets in Schedule 8 Fixed Assets. NTCA in its reply dated 10th September 2014 stated that the break-up of cost of hardware, software etc. is not available. Therefore, the amount could not be reflected under "Fixed Assets". The details may be obtained at the earliest and reflected in the Annual Accounts of NTCA for the year 2014-15.



- (ii) CPWD advance of Rs. 65.91 lakh is outstanding since 2008-09. The assets created out of this advance are, however, being used since 2009-10. It is therefore suggested that advance may be got adjusted immediately and depreciation may be provided to these assets since the year, assets were put to use.
- (iii) Grants-in-aids register was not maintained, in the absence of which status of outstanding UC's of grants-in-aid released by NTCA to various Tiger Reserves/ Grantee institutions upto 31-03-2014 is not available. The register may be maintained now and compliance may be show to audit.
- (iv) Schedule 11 Current Assets, Loans, Advances etc., 2. Advances and other amounts recoverable in cash or for value to be received. Under this head Rs. 40,55,115 released during 2012-13 also includes Rs. 3389600 released to CPWD. This amount may be excluded from this head and the same may be included under Advance Payments to CPWD.
- 6. Scrutiny of receipt of utilization certificates of outstanding grants-in-aid revealed that the following amounts of grants-in-aid were lying unspent with the grantee institution. The same may be got refunded at the earliest and either refunded to MoEF or revalidated from MoEF.
